I, the undersigned **Participant**, hereby agree as follows:

- a) **To Waive Any And All Claims** of every nature and kind at law or equity or under any stature that I have or may have in the future against the **Organization**.
- b) **To Release The Organization** from any and all liability for injury, death, property damage, property loss or any other loss or expense that I may suffer or that my next of kin or legal representatives may suffer as a result of participation in or use of **Event**, due to any cause whatsoever, including negligence on the part of the **Organization**;
- c) **To Hold Harmless And Indemnify The Organization** from any and all liability for injury, death, property damage, property loss or any other loss or expense to any party, including myself, as a result of participation in or use of the **Event**, or other financial loss or expense including, without restriction, legal expenses and costs on a solicitor-and-his-own-client full indemnity basis in defending against such claims or enforcing the terms contained within this document; and
- d) **That This Agreement Will Be Effective And Binding** Upon myself, and my heirs, next of kin, executors, administrators and assigns.
